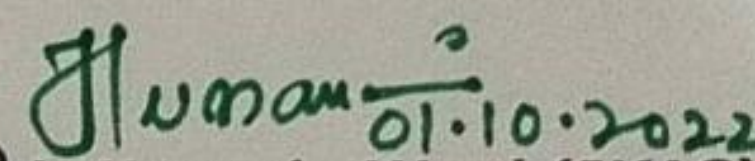
Subject: Low performance in achieving the targets under SBM-(G), serving of Notice - thereof

Whereas, an amount of Rs1.00 Crore was released in favour of all Block Development officers under SBM-(G) for making payments to (IHHLs) BLS,LOB,NOLBs toilets for new Households, Solid Waste Management, Liquid Waste Management, CSCs vide this office Order No:-ACP/K/SBM/11 of 2022 Dated:-26-09-2022 with the directions to clear the genuine claims of pendencies.

Whereas worthy District Development Commissioner, Kishtwar held a review meeting through virtual mode on 16th September 2022 and in conference hall of DC Office Complex on 27th September 2022 wherein clear directions were given to make payments of genuine claims, within four days and improve Parametrs of Nasha Mukh ,SHS,village basic information for ODF-Plus and uploading of data for Nomination of Panchayat awards in different categories on different Portals, besides long financial pendency under SBM-(G) was discussed and directions were given to give a vide publicity to the Notice Issued by Director Rural Sanitation ,J&K, Srinagar regarding all pending claims to be decided in the special camps organized from 26th to 28th of September,2022,however no substantial performance has been achieved by all Block Development officers.

Whereas, several other important issues like Nasha Mukh Bharat,SHS,village basic information for ODF-Plus and uploading of Data for Nomination of Panchayat awards in different categories on different Portals status was also reviewed on 01-10-2022 and all Block Development Officers were directed to upload all the pending entries on different portals. However despit clear directions District performance could not be improved and the district remain in red zone.

Now, keeping in view the above, you all are directed to improve your performance of all indicators under SBM-(G) and other sectors within week's time positively otherwise your case shall be recommended for disciplinary action to the higher authorities.
