Annexure - 1 (Proposed user fee structure)

The following monthly fee structure to levy & collect user fee for management of solid waste management from various waste generators shall be implemented across the whole Panchayat.

User Charges for Solid waste management from various waste generators (per month)

1. Households. $\text{Rs} = 100/- \text{ P/month}$
2. Shop and Commercial establishments: $2500 \text{ sq. ft} = 100/- \text{ P/month}$
3. Restaurants, eateries and canteens $750 \text{ sq. ft} - 200/- \text{ P/month}$
 $> 500 \text{ sq. ft or more} = 400/- \text{ P/month}$
4. Hostels and lodging $= 500/- \text{ P/month}$
5. Govt. private Banks Police offices, $= 200/- \text{ P/month}$
6. Hospital and health care centre $= 500/- \text{ P/month}$
7. Educational institutions $= 200/- \text{ P/month}$
8. Residential institutions sch/collage $= 500/- \text{ P/month}$
9. Industries including godown, Cold
 micro industries stores $= 250/- \text{ P/month}$
 Small industries $= 500/- \text{ P/month}$
 medium industries $= 1000/- \text{ P/month}$

Marriage halls, haats, exhibitions, bus stands, and places of community assembly: - 1000 = /p/event

Proposed penalty provision A meeting of the taluk Panchayat Committee on solid waste management shall be convened every month to decide and levy a one-time fine on the offenders for littering or burning of wastes.
