- The expenditure shall be incurred strictly as per the conditions laid down in the Beams order reflected above and the conditions laid down in the sanction letter of Govt. of India.
- Mission Director, JKSRLM shall further release /disburse the funds through Public Financial Management System (PFMS).
- 4. The funds shall be utilized as per the approved action plan 2020-21 and prescribed guidelines of the Scheme.
- 5. Mission Director, JKRLM shall submit Utilization Certificate of advance drawl to the Accountant General , J&K as well as Govt. of India as early as possible definitely before 31.03.2022 with a copy to the Administrative Department..

- 6. The funds shall not be available for re-appropriation/diversion at any level.
- 7. The funds shall be utilized for the purpose for which these have been released and strictly as per originally approved components.
- 8. The monthly progress report both physical/ financial shall be submitted on regular basis to Administrative department for monitoring of expenditure.
- 9. Director Finance, Department of Rural Development & Panchayati Raj shall vouchsafe the availability of funds.
