- 7. The Implementing Agencies shall ensure that there is no duplicity in the works/source of funding with other schemes.
- 8. The funds shall not be parked un-necessarily.
- 9. Director Finance, Department of Rural Development & Panchayati Raj Shall vouchsafe the availability of funds.
