The appointee(s) shall be allowed to join only on production of the following documents/certificate in original to be verified subsequently:-

- i. Academic/Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the Concerned CMO of the District.

- v. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vi. Category certificate, if any.

The appointment of the appointee(s) shall further be subjected to the following conditions:-

- i. If, on verification, genuineness of the qualification certificates or any other documents from the concerned issuing authority is found fake/foraged, the claim of the appointee for appointment as Class-IV shall also be deemed to have been cancelled ab-inito and the legal action as warranted under rules shall be initiated against him.
- ii. The salary of the appointee (s) shall be drawn and disbursed to him unless satisfactory report in respect of qualification/other certificate are received from the concerned authority.
- iii. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated: 24.12.2009.
- iv. The appointment shall be made in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020, notified vide S.O 192 of 2020 dated 17.06.2020.
- v. The Cadre/Departments allocation by appointing authority/Service Selection Board shall not be changed under any circumstance by any authority/Department.
- vi. The appointments shall be cancelled ab-inito if it is found that the candidates having higher qualification then the prescribed one at any stage later on, he shall also be liable for criminal prosecution
- vii. All the appointment orders shall be issued subject to outcome to any petition (s) pending in any competent Court/ Tribunal etc.
