- Mission Director, JKRLM shall further release/disburse the funds through Public Financial Management System (PFMS).

- Mission Director, JK Rural Livelihood Mission shall submit Utilization Certificate of 5. advance drawl to the Accountant General, J&K as well as Govt. of India as early as possible definitely before 31-03-2023 with a copy to Administrative Department.
- The funds shall not be available for re-appropriation/diversion at any level.
- The funds shall be utilized for the purpose for which these have been released and strictly as per originally approved components.
- The monthly progress report both physical/ financial shall be submitted on regular basis to Administrative for monitoring of expenditure.
