Sanction is hereby accorded to release along with its advance drawal of funds amounting to **Rs 500.47 lakh (Five Crore and Forty Seven thousand only)** in favour of Mission Director, JKRLM as due **matching UT share against** 1st tranche of 1st installment of Central Share for implementation of National Rural Livelihoods Mission (NRLM)/Ajeevika during FY 2022-23 in UT of Jammu & Kashmir .

The release/advance drawl of funds shall be subject to the following conditions:-

1. The funds shall be utilized after observing all codal formalities /procedures to maintain financial discipline.
2. The expenditure shall be incurred strictly as per the conditions laid down in the BEAMS order referred above and the conditions laid down in the sanction letters of the Govt. of India.
3. Mission Director, JKRLM shall further release/disburse the funds through Public Financial Management System (PFMS).
4. The funds shall be utilized strictly as per Approved Action Plan 2022-23 and prescribed guidelines of the scheme.
5. Mission Director, JK Rural Livelihood Mission shall submit Utilization Certificate of advance drawl to the Accountant General, J&K as well as Govt. of India as early as possible definitely before 31-03-2023 with a copy to Administrative Department.
6. The funds shall not be available for re-appropriation/diversion at any level.
7. The funds shall be utilized for the purpose for which these have been released and strictly as per originally approved components.
8. The monthly progress report both physical/ financial shall be submitted on regular basis to Administrative for monitoring of expenditure.
9. Director Finance/CAO/Account Officer, Department of Rural Development & Panchayati Raj shall vouchsafe the availability of funds.


