The funds shall be utilized through Public Financial Management System (PFMS) for carrying out the following activities: -

- I. Activities to sensitize and impart habitat and housing literacy to beneficiaries.
- II. Construction of prototypes of house typologies for demonstration.
- III. Cost of supervision and monitoring of scheme implementation including mobility, IT (hardware and software) and Communications systems, office contingencies, incentives etc.
- IV. Conduct of assessments and studies including evaluation studies.
- V. Cost of demonstration of innovative technologies and works related to housing.
- VI. Cost towards monitoring the quality of construction of PMAY(G) houses.
- VII. Social Audit and IEC activities.
- VIII. Training of officials and elected representatives of Panchayats including exposure visits.

The executing/implementing agencies shall incur the expenditure subject to the following conditions: -

1. The expenditure shall be incurred after observing all Codal formalities to ensure financial discipline as per the guidelines of the scheme.
2. The audited statement of expenditure and utilization certificate in prescribed format of Govt. of India be submitted to Adm. Department for its onwards submission to the MORD, Gol.
3. The funds shall be utilized for the purpose for which these have been released after fulfilling all the Codal formalities and no diversion/re-appropriation is allowed at any level.
4. ACDs shall further release 60% of the released funds in favor of BDOs in proportion to the completion of houses and retain up to 40% only at District level.
5. Further release of funds to the BDOS shall be made within a week's time.
6. No diversion/re-appropriation of funds at any level is allowed.
