5. Joint Director (Planning) shall provide a Laptop to the team for smooth conduct of official business.
6. ACDs to ensure that data collected from block level camps during 20-27th November is also made available to the team.
7. Concerned BDOs shall also arrange the required meetings with beneficiaries of pending IAY/SECC/AwaasPlus cases with the team, to understand the causes for delay and possible solutions.
