In terms of Govt. Order No. 223-RD&PR of 2022 dated 02.09.2022, sanction is hereby accorded to the release of funds to the tune of Rs. 25,00,000 (Twenty Five Lakh Only) in favour of Deputy Commissioner, Srinagar, for its payment as ex-gratia relief to the next of kins (NoKs) of Sameer Ahmad Bhat S/o Abdul Rashid Bhat, deceased Sarpanch, Khomoh-C, R/o Kati Mohalla, Khonmoh, Panthachowk, Srinagar.

The release of funds is subject to the following terms & conditions;

- 1. That the eligibility for payment of ex-gratia relief shall be assured in terms of guidelines/orders issued by the Government from time to time.
- 2. All codal formalities shall be followed before release of ex-gritia relief in favour of next of kins (NoKs) of ex-Sarpanch.
- 3. No diversion of funds shall be made from one component to another without prior approval of competent authority.
- 4. The DDO shall obtain all necessary documents before release of relief as required for the purpose as per the Government orders/guidelines issued on the subject.
